#### What are cookies?

Cookies are small text files stored on your device (computer, smartphone, tablet) when you visit a website. They are widely used to make websites work efficiently, as well as to provide information to site owners. Cookies can be:

- 1. **First-party cookies**: set by the website you are visiting
- 2. **Third-party cookies**: set by domains other than the website you are visiting

# Types of cookies we use

We use different types of cookies for different purposes. Below is a breakdown of the categories:



Cookie Type	Purpose	Examples	Retention
Functional	Improve general performance and functionality of the website.	To allow easy login or remember a user's region.	Depending on the purpose of the types of cookies, it can vary from session only to up to 10 years (depending on browser settings).
Performance	Track website visitors and their user behaviour.	To improve the way the website works and in turn, used to improve user experience.	Depending on the purpose of the types of cookies, it can vary from session only to 13 months.
Marketing	Track user behavior for advertising and social media purposes.	To collect data on interactions, preferences, and habits.	After 7 days data will be made pseudonymous and stored for another 180 days.

# Lawful basis for collecting and processing personal data

We rely on the following legal bases under the GDPR:

- 1. Consent for all non-essential cookies (i.e. targeting, advertising, analytics, etc.) we rely on your consent. Consent is collected via the cookie banner
- 2. Legitimate interest for strictly necessary cookies needed to deliver website functionality You may withdraw or modify your consent at any time by adjusting your preferences through our Cookies Script cookies consent manager.
