1. PREAMBLE TO THE TERMS OF USE

Before using this Platform (https://knowledge-hub.circle-economy.com/) along with any related Platforms, networks, applications, and services provided by Circle Economy Foundation, we ask you to carefully read the Terms and conditions outlined in the Terms of Use (hereinafter referred to as the "Terms"). These Terms contain important information in respect of the Platform use, as well as significant information and warnings about service provision you may receive using the Platform. You are required to acquaint yourself with these Terms before proceeding with the use of the Platform.

2. DEFINITIONS

"Knowledge Hub", "Platform" is an online platform for people around the world for reading and publishing articles and ideas that address a universal question or problem.

"Circle Economy Foundation" means Circle Economy Foundation, a legal entity with its registered office at: Mauritskade 64, 1092 AD Amsterdam, registered number: KVK: 52051048, and all its affiliates.

"User", "You" is a natural person, who uses the Platform under the Terms and conditions defined in these Terms, as well as is a party to these Terms.

3. GENERAL TERMS AND CONDITIONS

These Terms constitute the entire and exclusive understanding and agreement between Circle Economy Foundation and you relating to the use of the Platform, and supersede and replace any all prior oral or written understandings or agreements between Circle Economy Foundation and you regarding the same. If for any reason a court of competent jurisdiction finds any provision of these Terms invalid or unenforceable, such provision will be deemed omitted and the other provisions of these Terms will remain in full force and effect.
